**Correction of material errors in previous annual report**

Subject to the approval of the Attorney-General and subsequent tabling in Parliament, the following errors were identified in the 2006-07 Family Court Annual Report.

The performance target figures quoted in the Family Court Annual Report Table 3.6, Time to Finalise Applications for Final Orders 2003-04 to 2006-07, on page 51 were incorrectly reported. A typesetting error has caused the target figures to be offset by one row in the table and therefore they do not align with the correct performance figure. The correct target figures should have been printed one row down from their current position.

This error has also affected the adjoining Figure 3.17 that presents the target percentages. The target figures should read 90% and 95% respectively, not 75% and 90% as printed. The first paragraph explaining the data therefore contains the incorrect target figures quoted in the text.
